FACILITY POLICIES

We welcome you to McAvoy Park. So that you might enjoy your stay we ask that you familiarize yourself with the "Policies" of this park.

PARKING

- Permitted in those areas designated as parking spaces.
- Handicap parking spaces are **RESERVED** for only those cars with proper handicap identification. All others will be towed at the owner's expense.

PROHIBITED ACTIVITIES/SUBSTANCES

- **THERE ARE NO EXCEPTIONS** to McAvoy Park's designation as a tobacco, alcohol and pet-free facility.
- All **GOLF** activity is prohibited.
- Outside food and drink, with the exception of water, **MAY NOT** be brought into McAvoy Park at any time.
Food and drink purchases may be made at the concession stand located in the concession/restroom building.
- Spectator seating is allowed only in the bleachers. Chairs of any kind are not allowed on the turf.
- **DUGOUTS:** Only team members are allowed in the dugout(s). Children, fans or other non-team members are not allowed in the dugout(s).
- Gum, candy, food, or seeds of any kind **MAY NOT** be brought onto the field, to the team benches or into the team dugouts. Evidence of any of the former will result in a \$25.00 fine.
- Glass containers are prohibited everywhere in the park.
- Skateboards, roller blades, roller skates, bicycles, scooters are not allowed in the park.
- Passing, kicking or throwing of soccer balls, footballs or baseballs is not allowed on the pavers in front of and on the sides of the building.
- Warm-up activity(s) are not allowed on the pavers in front of or on the sides of the building.
- **SHIRTS AND SHOES MUST BE WORN AT ALL TIMES.**
- Children are not allowed to play under or on the bleachers.

PROPER CONDUCT

- Organizations, team coaches and managers are responsible for the actions of all individuals, including spectators, associated with their organization.
- Organizations, team coaches and managers are responsible for compliance with all rules, regulations and policies of McAvoy Park by all individuals, including spectators, associated with their organization.
- Actions in violation of rules, regulations and policies of McAvoy Park by spectators, coaches and/or players may lead to the suspension, termination or forfeit of a game/match.

Continued violation of rules, regulations and policies could lead to denial of future use of the park.

- An individual ordered to leave McAvoy Park by either a game official or a McAvoy Park Staff member, must immediately leave the premises, including the parking lot.
- Verbal abuse or physical abuse of game officials or McAvoy Park Staff members will not be tolerated.
- Parents or Legal Guardians are responsible for the behavior of their children.
- SHIRTS AND SHOES MUST BE WORN AT ALL TIMES.

WEATHER – THUNDER/LIGHTNING POLICY:

- If thunder and/or lightning is observed at the Park by the officials 30 or fewer minutes **PRIOR** to the scheduled start of that contest, the officials and the responsible Town authorities shall not permit the contest to begin until the weather has cleared.
- If thunder and/or lightning are observed at the Park by the officials **DURING** a contest, the officials and responsible Town authorities shall immediately cease play, wait for 15 minutes and re-evaluate the situation. In the event a contest is interrupted due to weather conditions a contest may be deemed complete in compliance with league rules. **e.g.** a run differential of 10 runs or more exists and 5 innings have been completed the game will become official at that point.

INJURIES/MEDICAL EMERGENCIES

- We recommend that managers and coaches carry medical release forms, medical kits, ice packs [which are not recommended for facial area near eyes], blood kits and extra uniforms.
- **PLAYERS WITH BLOOD ON THEIR UNIFORMS WILL NOT BE ALLOWED TO CONTINUE.**

ASSUMED RISK

- Participants and spectators acknowledge that participation in or attendance at a sporting event may result in injury.
- Participants, spectators and guests assume all risks of injury incurred or suffered while on the premises, or as a result of using the facilities available to them.
