2. Rosters are limited to fifteen players per team (minimum age: 16 years). Complete rosters are due upon registration. Final rosters (names of all players) are due **Friday, December 18.**
3. Each team is scheduled for two pre-season and ten league games. The top four teams in each division qualify for the District Championship playoffs (two weeks).
4. Teams are classified based on their previous league performance and current player personnel, and pre-season games.
5. Two scorekeepers are scheduled for each game and are included in league fees.
6. Each team is required to pay a \$27 official's fee (cash) prior to each game. Official's fees are not included in league fees.
7. Awards are presented to League Champion and Second Place teams: one team and ten individual awards. District Playoff Champion: one team award.
8. Pre-season play begins **Monday, December 7, 2009.** League play starts **Monday, January 11, 2010.**
9. All teams **MUST** have uniforms. Reversible color shirts are recommended. All shirts must have numbers and be uniform in color.

13. **IN-DISTRICT/OUT-OF-DISTRICT**

In-District teams must meet one of the following requirements:

1. Have no more than two players residing outside Conejo Recreation & Park District boundaries (Thousand Oaks, Newbury Park, and the Ventura County portion of Westlake Village).
- OR-**
2. Be sponsored by a company or business located within Conejo Recreation & Park District boundaries, in which case, all employees of that company are considered In-District. (There may be no more than two non-employees on the team who reside outside of the District).

Any team NOT meeting one of the above two requirements will be classified as an Out-of-District team.

If you are uncertain of District boundaries, please call the Sports Office prior to submitting application. Any team registered as an In-District team that is later found to be an Out-of-District team must pay balance of Out-of-District fees.

14. League fee includes SCMAF Players Medical Fund (\$500 maximum reimbursement). Recommend upgrade to SCMAF Accident Protection Program, \$15,000 medical insurance for an additional \$74. Contact the Sports Office for more information.

15. **IN-DISTRICT REGISTRATION MAIL-IN REGISTRAION-** Fill out the enclosed registration application completely. Send application and league fees to:

Priority is awarded to In-District applications and fees received on or before **Thursday, November 12**. Application may be faxed to 805/381-2726. VISA and MasterCard are accepted.
16. **LATE IN-DISTRICT/OUT-OF-DISTRICT REGISTRATION - If space is available.**
Registration is accepted at Hillcrest Center/Sports Office beginning **Friday, November 13**. Applications are processed on a first come, first served basis. Full league fees must be paid to register.
17. **MANAGER'S MEETING**
There is a **MANDATORY** Manager's Meeting on **Wednesday, November 18, 6:30 p.m.** at Hillcrest Center, 403 West Hillcrest Drive, Thousand Oaks. All manager's and/or assistant managers are required to attend. League rules and conditions of play are discussed; basketball rule books and CRPD Manager's Handbooks are distributed. Managers also vote on awards.
18. **LOTTERY**
Every attempt is made to place teams in the league; however, in the event In-District registration requests exceed available spaces the following occurs:
 1. All valid In-District applications received on or before the registration deadline are subject to a public lottery during the manager's meeting.
 2. Teams NOT represented at the manager's meeting are placed in the lottery first.
 3. Teams represented at the meeting are placed in the lottery only if necessary.
 4. Teams eliminated by lottery are automatically refunded their fee and placed on a waiting list.
19. **FORFEIT PROCEDURE**
The refundable forfeit fee is not included in league fees. Each team is required to provide a valid credit card number which is charged only if a team forfeits without paying officials at the site.
20. **REFUND POLICY**
Refunds will be granted to sports league and tournament teams prior to final confirmation of team schedules. **REFUNDS WILL NOT BE GRANTED AFTER TEAM SCHEDULES HAVE BEEN ESTABLISHED.**
