

SECTION 16 - PENALTIES:

ARTICLE 1 - GENERAL:

- A. The Referee will call all penalties.
- B. All penalties will be assessed from the Line of Scrimmage except as noted (spot fouls).
- C. Only the team captain or head coach may ask the Referee questions about rule clarification and interpretations. Players may not question judgment calls.
- D. Games may not end on a defensive penalty unless the offense declines it.
- E. Penalties are assessed live ball then dead ball. Live ball penalties must be assessed before a play is considered complete.
- F. Penalties will be assessed half the distance to the goal yardage when the penalty yardage is more than half the distance to the goal.
- G. Flagrant contact fouls will not be tolerated. Offending player(s) will be ejected from that game.

ARTICLE 4 - OFFENSIVE PENALTIES:

ARTICLE 5 - GENERAL PENALTIES

Fighting	10 yards from Line of Scrim- mage, Ejection

Conduct Unbecoming	10 yards from Line of Scrimmage

ARTICLE 6 - ALL-BUT-ONE ENFORCEMENT PHILOSOPHY: En-

forcement philosophy is based on the fact that a team is given the advantage of the distance which is gained without assistance of a foul. It is assumed that the only foul which would give us this aid is a foul by the offense behind the basic spot. Therefore, all fouls but this one, that is a foul by the offense behind the basic spot, are penalized from the basic spot, unless it occurs behind the Line of Scrimmage. Then it is assessed from the Line of Scrimmage.

EXCEPTION: Any foul that occurs by the offense in their own end zone shall be ruled a safety.
