Acknowledgement of Risk and Release; Rules of Participation

Please read this form carefully and be aware in registering yourself for participation in this program you will be acknowledging the risk and releasing all claims which you may have as a result of participating in this program.

I, the undersigned Participant, voluntarily consent to attend the Event. In consideration for the opportunity to attend, I agree to assume all risks of loss and injury that may arise out of my attendance and participation in the Event, and I agree to waive any and all claims against the City, both collectively and individually, and against all other Event participants. Participant hereby releases and forever discharges the City from any claim whatsoever that arises or may hereafter arise as a result or on account of any first aid, treatment, or service rendered in connection with my attendance or participation in the Event.

I understand that there are inherent risks involved in attending the Event and participating in the Event, including but not limited to equipment failure, instructional failure, perils of the surface or facility in which the Event is conducted, acts of other Event participants, and my own physical condition, and I hereby assume all such risks. I understand that I am voluntarily attending and participating in the Event with full knowledge of the nature of the danger or potential danger involved and hereby expressly agree to accept any and all risks of property damage, personal injury, or death to Participant as a result of such attendance or participation. I further acknowledge and understand that I am solely responsible for my behavior, for using all safety equipment properly, and for complying with all safety instructions and guidance.

In consideration of being permitted to attend and participate in the Event, I agree to release, waive, and discharge any claims against the City, its elected and appointed officials, agents, employees, and volunteers (collectively the "Released Parties"), and covenant not to sue the City or the Released Parties for injuries or damages sustained by Participant as a result of such attendance and participation. I further agree to indemnify, defend, and hold harmless the City and the Released Parties from any and all liability actions, causes of action, debts, claims, and demands of every kind and nature whatsoever that may arise during the course of or as a result of my attendance at or participation in the Event.

I understand, acknowledge, and agree that this Release is governed by the laws of the State of Colorado, is intended to be interpreted as broadly as possible, and shall be binding to the fullest extent of the law. I agree that exclusive jurisdiction and venue for any legal action arising from Participant's attendance at and participation in the Event shall be in the District Court of Jefferson County, Colorado. Nothing in this Release shall constitute a waiver or limitation on any right or immunities possessed by the Released Parties pursuant to C.R.S. §24-10-101, et seq., or any other applicable legal authority. I agree that if any part of this Agreement is determined unenforceable, all other parts shall be given full force and effect.

Fighting, verbal abuse, and alcohol use will not be tolerated. Any player(s) fighting and/or guilty of verbal/alcohol abuse of any kind will be eliminated from league play for the remainder of the season. The Golden Police Department may be called to respond to any incident.
