You are solely responsible for determining if you or your minor child/ward is physically fit and/or skilled for the activities or programs contemplated by this agreement. It is always advisable to consult a physician before undertaking any physical activity, especially if the participant is pregnant, disabled in any way or has recently suffered an illness, injury or impairment.

#### WARNING OF RISK

Recreational activities or programs are intended to challenge and engage the physical, mental and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury when participating in any recreational activity. Understandably, not all hazards and dangers can be foreseen. Depending on the particular activity, participants must understand that certain risks, dangers and Injuries due to inclement weather, slips and falls, poor skill level, conditioning, carelessness, horseplay, unsportsmanlike conduct, premises defects, inadequate or defective equipment, inadequate supervision, instruction or officiating, and all other circumstances inherent to indoor and outdoor recreational activities exist. I recognize and acknowledge that there are certain risks of physical injury to participants in these programs and activities, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish
