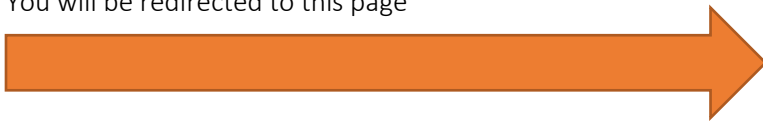
If you coach multiple teams, each team will automatically be assigned to your account and you can manage them as well.

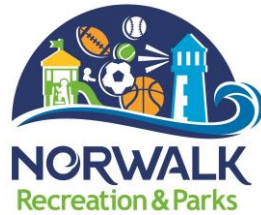

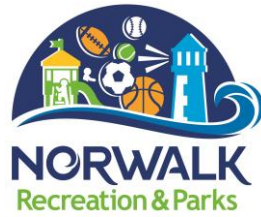
When you click HOME on the top left hand side of the page you will see the dashboard.

You will see a page called Team Roster for 'Team Name'

You will see 10 spots to enter your roster. You **HAVE TO ENTER** - Name and last name, phone number, email and DOB. The rest is not mandated.

If you have more than 10 players, enter the first 10, click on 'Save changes' and more lines will populate.

Once you 'Save changes' your players will receive an email to either or in or create an account. Once they log in the first thing they will see is their waiver. If you are also a player on your team as well as Manager/Captain, you will need to add yourself to the roster to see the waiver. Read the waiver, check the box, confirm your name and email are accurate and click

'Submit Waiver'

1. **Release, Waiver and Covenants.** In consideration for participating in the Activity, the Participant hereby acknowledges and agrees to the following:

a. **Release and Waiver of Liability.** The Participant, on behalf of him/herself, and his/her representatives, heirs, executors, administrators, agents, and assigns, HEREBY RELEASES, WAIVES, DISCHARGES, AND COVENANTS NOT TO SUE the City of Norwalk, and its officials, employees, servants, agents, and representatives (hereinafter referred to as "Releasees") for any and all liability, including any and all claims, demands, causes of action (known or unknown), damages, suits, or judgments of any and every kind (including attorneys' fees), arising from any illness, disease, injury, property damage or death that Participant may suffer as a result of his/her participation in the Activity, REGARDLESS OF WHETHER THE ILLNESS, DISEASE, INJURY, DAMAGE OR DEATH IS CAUSED BY THE RELEASEES, UNLESS THE INJURY, DAMAGE OR DEATH IS CAUSED SOLELY BY THE RELEASEES' GROSS NEGLIGENCE OR INTENTIONAL ACTS.

a. **Assumption of Risk.** Participant understands that there are potential dangers incidental to participating in the Activity, some of which may expose Participant to the risk of serious personal illness, injuries, property damage, or even death. PARTICIPANT KNOWINGLY AND VOLUNTARILY ASSUMES ALL RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE ACTS OF THE RELEASEES, UNLESS THEY ARISE FROM THE RELEASEE'S INTENTIONAL OR GROSSLY NEGLIGENT ACTS.

a. **Indemnity.** Participant, on behalf of his/her self and his/her personal representatives, heirs, executors, administrators, agents, and assigns, agrees to indemnify and hold harmless the Releasees from any and all liability, including any and all claims, demands, causes of action (known or unknown), suits, or judgments of any and every kind (including attorneys' fees), arising from any loss, illness, injury, property damage or death that Participant may cause or suffer as a result of participating in the Activity, REGARDLESS OF WHETHER THE INJURY, DAMAGE OR DEATH IS CAUSED BY THE RELEASEES OR OTHERWISE, UNLESS THE INJURY, DAMAGE OR DEATH IS CAUSED BY THE RELEASEES' GROSS NEGLIGENCE OR INTENTIONAL ACTS.

THE PARTICIPANT HAS READ THIS AGREEMENT AND FULLY UNDERSTANDS ITS TERMS. THE PARTICIPANT IS AWARE THAT THIS AGREEMENT INCLUDES A RELEASE AND WAIVER OF LIABILITY, AN ASSUMPTION OF RISK, AND AN AGREEMENT TO INDEMNIFY THE RELEASEES.
