President – Randy Netherda

1. PCSSA will be holding its annual election of officers from **March 3-7, 2025**, for a term beginning May 1, 2025. The election will be online, secure and anonymous. You may find the league officer roles and responsibilities under the tab "League Documents" on the league website. There are four (4) open positions for election:
 - Vice President (1-year term, then President for 1-year)
 - Secretary (2-year term)
 - Director of League Personnel (2-year term)
 - Director of Field Maintenance (may be 1 or 2-year term)

2. The schedule details for Playoffs and End of Season tournament are posted on the website. Playoffs will include the Top 4 teams in each League. These games will be held between Monday, Mar 31st and Friday April 11th.

Vice President – Bob Pahl

1. Final day for purchasing jerseys for Fall/Winter was January 18th. No more team jerseys will be purchased.
2. Spring registration details:
 - Registration is from Feb 1st to Feb 28th
 - Opening day is tentatively scheduled for April 12th and the season will run for 6 weeks, ending on May 17th. Final determination of dates will be made based on the completion of the Fall/Winter tournament. Game days are Tuesday, Thursday and Saturday.
 - Rule change considerations should be submitted to Mark Roberts as soon as possible.
 - Draft is tentatively scheduled for Mar 18h. Players will not be re- rated for Spring. Spring draft will be based on Fall/Winter ratings.
 - Managers are needed. Please let any Board Member know if you are interested. Special consideration will be given to those who are contemplating managing during the 2025-26 Fall/Winter season. Great opportunity to explore the leadership role.
 - Membership was surveyed for sentiment on whether the Spring should be competitive or for development. Roughly two thirds preferred a competitive schedule.
 - The following registration fees will apply:
 - * \$70 – Player Fee
 - * \$45 – Assistant Manager/Coach Fee
 - * \$45 – Sub List Fee if not on a Fall/Winter roster
 - * \$20 – Sub List Fee if on Fall/Winter roster
 - The new Flex Fit Hat will be ordered this year for all players. You can now try these on at the field to determine your size.

Director of Field Maintenance – Jon Jackson

1. Frame for the tarp for the 1st Base bleachers was completed last week. This wraps around the bleachers and holds up better against the wind gusts.
2. Green Card is being submitted to the HOA to repair the fence and gate along the first base line.
3. HOA is planning for outfield improvements to the sprinkler system in 2026.

Director of Marketing – Marie Shubin

1. Working to identify team sponsors for the Spring League. Current plan is to have at least four new team sponsors.
2. Golf Tournament Committee is currently working through the many details. Registration for players and teams began Jan 6th and all 144 golfer positions have been filled. A Wait List has be activated.

3. Our PCSSA Night at the Ballpark is March 17th (Monday) at 6:05pm. The game is the Guardians vs Reds. Tickets are \$20 each. Still plenty of tickets are available. Contact Scott Beseda or Tom Bose to secure tickets and make payments.
4. End of Season Awards Banquet is April 10: No-host bar 5:00-6:00, Dinner 6:00-7:00; Program 7:00-8:00. Table sponsorship is available to all current team sponsors.
5. Onzo Award nominations should be submitted to Randy Netherda by March 6th.

Director of Player Personnel – Rich Christiansen

1. More evaluations were completed in February. Four new players been placed on the Sub List. The updated Sub list is on our website. Note: Only players that have paid their league fees are on the list.
2. As players are permanently placed on teams, they are removed from the Sub list. In the past month, two have become permanent replacements.
3. The Evaluation Committee has made their assessment of some players who were identified as playing well above the current rating. Two have been recommended to be moved plus two in their rating. The Board approved changes will become effective on Saturday, March 1.
4. Beginning in March, all current players will be re-rated/re-evaluated for the 2025-26 Fall/Winter Season.
