#### **Meeting Items:**

#### **COVID-19:**

- Robson Field reopened 11 May
- The first 2 weeks of activity staggered between practice days and pickup game days
- Starting 25 May there will be 5 days each week of activity consisting of 2 practice days and 3 pickup game days
- Practice days are Monday & Wednesday; Pickup games are Tues/Thurs/Sat
- Personal bats not designated as a "hot bat" allowed during pickup games

Adjustments to protocols and play days will be adjusted as necessary;

Safety/Control Team led by Rappy will ensure all protocols are met

#### **HOA Maintenance:**

 Once HOA maintenance begins the field will close down to all activity except maintenance. When HOA maintenance project is completed the field will reopen

#### 2020/2021 Season:

- Will continue to plan & work with PCHOA for a Fall/Winter Season
- Registration will open 1 June and close 17 August
- Player fee of \$120 due 31 August
- Draft scheduled for Sat 12 September, 0900, Eagles Nest Ballroom
- Opening Day tentatively scheduled for 17 October, based on over seeding, possible to move to 24 October
- <u>COVID-19</u> may still be an issue so may have new protocols/recommendations to follow; will align with the SSUSA as close as possible
- Game schedule in work
- Currently have 3 managers not returning to manage; contact Doug Wainwright if interested in managing
- One to Waste (Closed Item)
- The Board sees no advantage to the league as a whole. PCSSA will not institute the 1 to waste rule for 2020/2021 season
- Will maintain 5 runs per inning
