ADULT SOFTBALL

PLAYER WAIVER, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT

I, the undersigned player or coach, acknowledge, agree and understand that:

1. Voluntarily and of my own free will, I elect to participate as a member of the softball team and league indicated below.
2. I understand that there are certain risks and hazards involved in participating in softball that may result in injury or death to me or other players, including, but not limited to those hazards associated with weather conditions, playing conditions, and other participants.
3. I understand that sliding into a base is dangerous to me and to other players and may result in serious injury or death.
4. I understand that the very nature of the game of softball is hazardous and risky, including, but not limited to, the acts of pitching, throwing, fielding and catching of the ball, the swinging of the bat, running, jumping, stretching, sliding, diving, and collisions with other players and with stationary objects, all of which can cause serious injury or death to me and to other players.

Further, I, the undersigned player, agree that in consideration for the right to play as a member of the team designated below and in consideration for permission to play in the fields arranged for by the team or league:

1. I VOLUNTARILY ELECT TO ACCEPT AND ASSUME ALL RISKS of injury incurred or suffered by me (a) while practicing or playing as a member of the team so designed, (b) while serving a non-playing capacity as a team member during practice or play by other teams or by other players on my team, and (c) while on or upon the premises of any and all of the fields arranged for by my team or league for practice or play, collectively referred to as my "Participation in the Event".
2. I RELEASE, DISCHARGE AND AGREE not to sue the City of Redwood City, its Council, Boards, Commissions, Officers, Employees and Agents, the team and league designated below, the field owner or other entity designated below, the Amateur Softball Association of America, or their Owners, Officers, Agents, Servants, Association of America for any claims, damages, costs or cause of action which I have or may in the future have as a result of injuries, death or damages sustained or incurred by me from whatever cause in connection with my participation in the Event, including by not limited to the negligence breach of contract or wrongful conduct of the parties hereby released.
3. I HEREBY WAIVE, RELEASE AND DISCHARGE ANY AND ALL CLAIMS for damages, death, personal injury or property damage, which I may have, or which may hereafter accrue to me, as a result of my participation in the Event. This release is intended to discharge in advance the City of Redwood City, it's Council, Boards, Commission, Officers, Employees and Agents of the team and league designated below, the field owner or other entity designated below, the Amateur Softball Association of America, or their owners, Officers, Agents, Servants, Associations, Employees, or any person or entity connected with team, league, field or Amateur Softball Association from and against any and all liability arising, out of or connected in any way with my participation in the Event, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.
4. It is further understood and agreed that this Waiver, Release and Assumption of Risk is to be binding on my heirs and assigns.
