#### Acknowledgment of Risk:

I recognize that participating in basketball carries inherent risks that may lead to physical or emotional injury, paralysis, permanent disability, death, or property damage. These risks may include, but are not limited to, broken bones, torn ligaments, bruises, and other serious injuries such as death or blindness, resulting from contact with basketballs, other participants, or structures like walls and bleachers. They may also arise from slippery or uneven playing surfaces, medical conditions stemming from physical activity, or damage to personal property. I understand that such risks cannot be completely eliminated, even with safety equipment, as it is essential for the activity.

I voluntarily accept and assume all risks associated with my participation, including those that may arise from the negligence of the Releasees. My decision to participate is entirely voluntary, and I acknowledge that if I ever feel that conditions are unsafe or that I am unable to participate due to physical or medical reasons, I will immediately stop participating.

I hereby voluntarily release, discharge, and agree to indemnify and hold harmless the Releasees from any and all claims, demands, or causes of action related to my participation in this activity, including any use of their equipment or facilities, that may arise from negligence. This release does not cover claims resulting from intentional misconduct. Should the Releasees or their representatives incur attorney fees and costs to enforce this agreement, I agree to indemnify and hold them harmless from such fees and costs.

I affirm that I possess adequate insurance to cover any injury or damage I may suffer or cause while participating in this activity, or I agree to cover all costs associated with such injury or damage myself. Furthermore, I confirm that I have no medical or physical conditions that could compromise my safety in this activity, or I willingly assume all risks arising from any such condition.

In the event that I file a lawsuit, I agree to do so exclusively in the state where the Releasees' facility is located, and I agree that the laws of that state shall govern the proceedings.

I understand that if any part of this agreement is found to be unenforceable, the remainder will remain in full effect.

**Waiver of Liability:**
