LEAGUE NOTE: The recreation department reserves the right to place teams in the division necessary to administer an equitable league.

- Input from the softball advisory committee will be considered.
- Teams are not guaranteed their choice of division and/or nights.

Rule Reminders for 2026

*****Please note*** Rules changes are based on results from the post season managers' survey, feedback from the softball advisory committee (SAC) and decisions made by the department. Rules are made for the best interest of the league based on this feedback.**

- Games on alternate nights
 - FRIDAYS will be used early in the season for men's and coed leagues to ensure that the seasons end as close to Labor Day as possible.
 - Men's games and coed games will not be scheduled on the same Friday as much as possible to avoid schedule conflicts when possible.
 - THURSDAYS will be used early in the season for the women's league to ensure that the season ends as close to Labor Day as possible.
 - Only two games will be scheduled on SKHS fast pitch softball game nights for the women's and coed leagues when possible to avoid late games.
- Roster additions –
 - Any player who has not played in a game for a team may be replaced on the roster by a new player.
 - EXAMPLE: A team has 25 players listed on the roster, but 4 have not played in a game. These 4 players may be replaced by new players. Once a player has played in a game, the player may not be replaced.
- 3 games will be played each night in regular season AND playoffs. Double headers will be played if needed to have 3 games played each night.
- Home team for playoffs
 - The better seeded team will be home throughout playoffs
- Men's league team promotion and relegation
 - Men's teams will be promoted and relegated to another division based on the following formula
 - Teams will earn points based on how they finish in the regular season and playoffs
 - Points will be given based on how many teams are in the division
 - If there are 6 teams in a division the 1st place team receives 6 points and the 2nd place team receives 5 points, etc.
 - Points earned in the playoffs will be doubled
 - Points are added together from the regular season and playoffs
 - The team with the most points will be promoted
 - The team with the fewest points will be relegated
 - The team with the most playoff points will be promoted in the event of a points tie
 - **“DYNASTY RULE”** - Any team who wins back to back playoff championships, regardless of points, will automatically be promoted
- Courtesy runners
 - Do not need to be “last batted out, last inning”
 - Runner will be the last batter to have caused an out
 - Example: Fly out, ground out, hitting into a fielder's choice, strike out
 - Once a designated player takes a courtesy runner, they MUST take a runner the remainder of the game
 - A designated player may NOT advance past 1st base. Once they get to first, they may not advance. If the player attempts to advance, the play is dead and runners return to their previous base.
- Lineups must be turned in 5 minutes before start time or the team will start the game with an out.

RULE REMINDERS

- CASUAL PROFANITY RULE -

- If any player on the field or on the bench is heard by the plate/base umpire or SKPR staff using CASUAL PROFANITY in an aggressive manner the next scheduled batter will be called out. If the player aggressively uses CASUAL PROFANITY while playing in the field, the next person due up in the lineup for the teams next at bat is out. (*i.e. when popping up, grounding out, swinging & missing, dropping a fly ball, overthrowing a base....you get the idea!*)
- Examples of words that would apply are: Sh*t, Motherf**ker, f**k, A**Hole, C**T, racial terms/slurs OR anything deemed inappropriate by the umpires or SKPR staff.
- ***Please note: Any conduct or profanity deemed unsportsmanlike, directed at any officials, spectators, or other players may result in an ejection in accordance with Article 215 Section B of the ASA Code.***
- Home run limits -
 - Women – 3, Coed – 3, D – 1, C – 3, B – 4, A – 5
- Grace period –
 - The clock for the no new inning after an hour and 15 minutes will start at 6:00pm, NO EXCEPTIONS.
 - The clock for the no new inning after 1 hour and 15 minutes rule starts at 1st pitch for any other games.
 - The official clock will be kept by the scorekeeper.
 - Games may continue to play after 10:00pm as long as they follow the no new inning after 1 hour and 15 minutes.
- South Kingstown Parks and Recreation adult softball leagues play by ASA rules with department modifications. We play with ASA bats and ASA softballs.
 - The ASA approved softball is a .52/300 ball. The ball is the same hardness regardless of the manufacturer.
 - We do not use a harder ball, such as the USSSA ball. Using USSSA softballs with ASA bats would damage the bats and the USSSA ball comes off the bat faster and creates safety issues for our recreational league.
- Player reentry
 - ASA rules allow a player to reenter the game 1 time for the SAME player
 - EXAMPLE: Player A is substituted for by Player B. Player A may reenter and substitute for Player B one time later in the game
- Courtesy runners
 - 2 players may be designated **BEFORE** the game begins that need courtesy runners
 - The letter “C” must be put next to the players needing courtesy runners on the lineup card
 - Courtesy runners for designated players MAY advance more than one base at a time
 - A courtesy runner for any player that was NOT designated may only advance one base at a time
 - If a player who was not designated takes a courtesy runner and is SUBSTITUTED in the lineup by the courtesy runner from the bench, the player may advance more than one base at a time
 - If a non-designated player is SUBSTITUED by a courtesy runner off the bench, the original player may re-enter for the same player later in the game per ASA rules.
 - EXAMPLE: Player A does not designate before the game. Player A takes a courtesy runner and is substituted by Player B from the bench. Player A may reenter the game for Player B one time later in the game.
- Players must play in a minimum of 7 games to be eligible for playoffs
 - Players who substitute a player to play in the field MUST be reported to the scorekeeper to get credit for playing in the game. DO NOT assume the scorekeeper sees the change in the field, especially if the change is made between innings.

Courtesy Runner at Home Plate

- The courtesy runner from home plate can be used for **one** individual per **Men's D Division team** who has a **medical exemption from running**. This individual must be indicated at the beginning of the season and cannot be changed throughout the season. Meaning, once you designate yourself in need of a courtesy runner from home plate you cannot change this status. The individual who needs a courtesy runner from home plate cannot participate in any positions on the field due to medical/injury precautions.
- This individual must provide a copy of a medical form with the exemption to the league supervisor, for approval. A batter can only have a runner if he has been cleared through a medical doctor and has the permission of the supervisor and committee through an email from the supervisor.
- The courtesy runner will line up behind home plate on the right side of home plate facing out to the field on the designated courtesy runner mark. He cannot run until the batter contacts the ball.
- That courtesy runner cannot run for anyone else that half inning whether the batter gets a hit or not. If the batter strikes out, that courtesy runner is done for the half inning. The courtesy runner for this individual must be the last batted out that inning. If the batter is the first up the next inning, the runner will be the last batted out in the previous inning. If this individual who needs a courtesy runner from home plate is first in the lineup, then the batters runner will be the person last in the lineup.
- The courtesy runner can only advance one base at a time.

2026 Rules Meeting

There will be a manager's meeting at the SK Recreation Center on **Thursday, April 9th** at 6:00 p.m. for ALL teams. Each team is asked to have **one** representative at the meeting.

Team Fees

The regular season will consist of 14 games. The fee includes a double elimination tournament at the end of the regular season. The fees are based on ALL leagues having two umpires. The fee is **\$1,100.00 per team.**

Team Practices

1. Teams may schedule one practice per week beginning April 4 (weather and field conditions permitting). Teams may call the Recreation Center 401-284-1975 every Monday beginning at 8:00 a.m. for the upcoming week. Practice fields can be reserved through the front desk personnel.
2. ***DO NOT E-MAIL OR ASK FOR TAYLOR – The Front Desk personnel at the Rec Center will assist you in scheduling practices.***

3. A facility permit will be emailed to the team manager. It is suggested the permit be printed and taken with you to practice.

Rain Make-Ups

1. Whenever possible, game status will be determined by 3:00 p.m. Please check the website www.southkingstownri.com and/or call 789-9301 **AFTER 3 P.M.** to check game status. When possible, www.quickscores.com/southkingstownri will also be updated.
2. Telephone calls are not normally made to managers advising of weather cancellations.
3. If the weather is questionable please contact the Neighborhood Guild at 401-789-9301 throughout the evening. Site supervisors will update front desk personnel as to game status.
4. Rain make-ups will be scheduled on Thursdays (women), Fridays (coed), and Fridays and/or Sundays (men).

ADULT SOFTBALL RULES

1. REGISTRATION / TEAM ROSTERS

- A. Each team must submit a roster of not more than twenty-five (25) players. The league fee (\$1,100.00 per team) must be submitted with the roster.

NOTE: *Rosters submitted without league fee and/or without phone numbers will be returned.*

MEN'S LEAGUE: Team members are allowed to play on more than one roster within the Men's League, but not within the same division and as follows:

Men's 'A' may play in either Men's 'B' or Men's 'C' divisions with a **maximum of 5 'A'** players on a 'B' or 'C' roster. An 'A' player is defined as anyone whose name appears on an 'A' roster.

Men's 'D', players can play on 1 a 'C' roster. 'D' division players are welcomed to play on a co-ed team.

****If a team is found to have six (6) or more A Division players: The current game will be forfeited. Any previous games played with more than five (5) A Division players will also be forfeited. Teams are responsible for ensuring their roster is always compliant. ****

- B. Managers may add players to their roster at anytime during the season as long as they stay within the 25 player limit without an add form. **Please email Taylor with the full name of the player and phone number. No player may be added beyond the 25 player limit unless they are replacing a player who has NOT played in a game.**
 - a. **REMINDER: Players must play in 7 games (50% of the regular season) in order to be eligible for playoffs.** The Supervisor may request player identification at the score booth if there is any question about a player's identity or eligibility. Players must provide valid ID when asked. Teams are responsible for making sure their roster is legal at all times.

- C. The Softball Advisory Committee will work with the department in the reviewing of NEW team rosters to determine divisions.

2. ELIGIBILITY

- A. All players must be 18-years old or scheduled to graduate from high school in June 2026.
EXCEPTION: Women's softball – each team may have three (3) 16/17-year olds on the roster.

3. GAME

SECTION A: Starting Times and Line-Ups

- It shall be the manager's responsibility to field a team for each scheduled game. Games will not be rescheduled for personal events such as weddings, vacations etc...**
- There is NO GRACE PERIOD FOR THE 6:00 PM GAME!! The no new inning after 1 hour and 15 minute time limit will begin at 6:00 PM according to the softball supervisor.**
- Starting times for Men's, Women's, and Coed game times are 6:00, 7:00, and 8:00 p.m.
- If games finish early, the 7:00 and 8:00 p.m. games will not start any earlier than the scheduled time unless agreed by **BOTH** managers.
(Note: The Site Supervisor is responsible for recording, monitoring, and informing the plate umpire of all game start times and time limits.)
- Line-ups are due five (5) minutes prior to each game's scheduled start time on the official lineup sheet. If line-ups are not handed in to the Site Supervisor before the game, the team will start their first time at bat with an out. Line ups must contain player's first and last names. No nicknames will be accepted.
- Once 9-players are present, the game will begin. There is no flipping Home and Away to accommodate a team with players in route. **A game may NOT start without having 9 players present from each team.**
- All Leagues – in the event of a team not having at least 9 players by the start of a game, and **BOTH** managers agree, a game may start late. In order for the game to be recorded as an official game, a complete 4 innings must be played. A game being played in these circumstances must play at least 4 full innings and stop at the scheduled start time of the next game. If a complete 4 innings is not finished the game is recorded as a forfeit win for the team that had a full team at the scheduled start time of the game.
 - Example: Team A arrives with only 8 players by their scheduled start time of 6:00pm. Team B has at least 9 players by the scheduled start time of 6:00pm. The manager of Team A and Team B agree to wait for the 9th player from Team A to arrive who is running late. The player arrives at 6:18pm and the game begins. The score is Team A 5 and Team B 4 at the end of 4 complete innings at 7:00pm. Does the score stand? **RULING:** Yes, the score stands. Both coaches agreed to start the game late, a complete 4 innings were played, and the game ended before the scheduled start time of the next game.
- Teams may field up to 11 defensive players plus an extra hitter (EH) on offense for a total of 12 players in the lineup. Once a team starts with an EH it must finish the game with one. The EH may switch to other defensive positions. A player may be added to the line-up any time during the first batting rotation. After the first batter has had the first pitch of his/her second time at bat, no players may be added. Substitutions may be made. If a player is dropped from the rotation, and no substitution is available, it is an out in the batting order. Batting out of order is appealable.
- If a team is playing with more than 9-players and one gets ejected and cannot be replaced, an automatic out will take place in that slot. If an ejection brings the team to 9-players, the game continues and will not be a forfeit.
- A team that gives notice to Steve by phone or email by 3:00 PM on game day of a forfeit, a forfeit fee will NOT be charged. If a team provides notice AFTER 3:00 PM on game day or is a NO SHOW/NO CALL at the field, a forfeit fee of \$75.00 will be charged and must be paid prior to the teams next scheduled game.
A team shall be removed from the league upon forfeiting three (3) games. If the Sports and Fitness Supervisor agrees to reinstate a team, a reinstatement fee of \$75.00 **MUST** be paid prior to playing the next game. Under special circumstances, the Director of Leisure Services may waive the team's removal from the league.

SECTION B: Pre-Game Procedures

- DESIGNATED RUNNERS:** Prior to the start of the game, the plate umpire will conduct a brief meeting with the managers of both teams. At this meeting, teams must designate players needing courtesy runners. There is a **maximum of two (2)** such players per team. The plate umpire will then inform the Site Supervisor if either team

has declared the need for a courtesy runner, the number of courtesy runners required, and the name(s) of the players designated as requiring a courtesy runner. These courtesy runners may advance bases normally. Any other courtesy runners not declared before the start of the game may only advance bases one at a time except for a home run, ground rule double, or two base award passed ball.

SECTION C: Equipment

1. All players must wear shirts of similar color and style. A number of contrasting color must be worn on the backs of the shirts. **ALL PLAYERS MUST BE IN UNIFORM BY JUNE 5th.**
After June 5th, any player not wearing a team uniform may not be allowed to play.
2. Metal spikes are prohibited.
3. Only Town provided bats may be used for games. Town provided bats MAY NOT be used for warmup hits.

SECTION D: Playing Rules

1. **A standard batters box will be used.** (ASA Rule 2 and Rule 7)
2. The limited arc is a minimum of 6-feet to a maximum of 10-feet from the ground shall be used. (ASA 6.3H).
3. A mat placed behind home plate as well as home plate itself will be used to determine balls and strikes. A pitched ball that hits any part of the plate (including the black edge) or mat will be called a strike. A pitched ball that does not hit any part of the mat or plate will be called a ball.
4. For all divisions, each batter will begin with a one (1) ball and one (1) strike count.
5. Each player will be given an extra foul ball if a foul ball is hit for a third strike. If another foul ball is hit, the batter will be called out.
6. Players are NOT required to slide. However, players will not be allowed to block, run into, or flagrantly attempt to dislodge the ball from another player. Infractions will result in an automatic out and may result in the player being ejected.
BENEFIT OF THE DOUBT WILL BE GIVEN TO THE DEFENSIVE PLAYER.
7. Each team is allowed two (2) designated runners each game. These players must be declared before the game starts. These two courtesy runners may advance bases normally. All other courtesy runners may only advance one base at a time except for home runs, ground rule doubles, and two base awards overthrown balls.
 - a. If the player deemed eligible for a courtesy runner advances beyond first base, the ball is dead and all other runners return to the last base touched at the time of the advance beyond first base.
 - b. If a player starts the game with a designated runner, they must take a runner the remainder of the game unless replaced in the lineup.
 - c. If a player substitutes for a non-designated player, they may advance more than one base at a time.
 - d. The player used as a courtesy runner will be the last player to cause an out
 - i. EXAMPLE: Fly out, ground out, hit into fielders choice, strike out, etc.
8. **NEW RULE- D League:** No team shall bat more than once through their batting order per inning. As a result, the last batter of the inning cannot be walked (intentionally or otherwise); the batter must put the ball in play or strike out. All games will begin at 6:00pm.
9. **Home Run Rule:** Men's 'A' – 5 home runs per game, Men's 'B' – 4 home runs per game, Women's, Coed, 'C' and 'D' – 1 home runs per game.
 - a. **Any ball hit over the fence that exceeds the home run limit is an OUT.**
10. Players are NOT required to touch 1st base or run the bases after a home run is hit for the home run to count. Players are allowed to CHOOSE to run the bases after a home run is hit.

11. **Game Time:** Each game has been allocated 1 hour and 15-minutes – if needed. **No new innings will be started after the 1 hour 15 minutes.** A game that is tied after 1 hour 15 minutes will remain a tie in the final standings. Game length will begin when the first pitch is thrown, except for the 6:15pm game when the clock starts at 6:15pm. Start time will be recorded by the Site Supervisor.
- a. If a team does not have 9 players by the scheduled start time, both managers may agree wait for the 9th player to arrive. The game must then finish before the start time of the next game. A minimum of 4 complete innings must be played in order for the game to count. If 4 complete innings are not played, the game counts as a forfeit to the team who did not have 9 players at the scheduled game start time.
12. **Run Ahead Rule Exception (a.k.a. Mercy Rule):** Twenty (20) runs after four (4) complete innings. Twelve (12) runs after five (5) completed innings. Complete innings **MUST** be played unless the home team is ahead. If behind, the home team will always receive the last bat.
13. Games that are cancelled due to weather/field conditions prior to 4 complete innings will be rescheduled and started over. Games that are cancelled due to weather/field conditions after **4 complete innings** have been played will be official. The final score will be the score at the end of the last COMPLETE inning.
- a. **EXAMPLE:** A game is cancelled due to weather in the middle of the 6th inning with TEAM B winning 16-12. The score at the end of 5 complete innings was TEAM A 12, TEAM B 10. Team A is declared the winner

SECTION D: Women's League

14. No team shall bat more than once through their batting order per inning. As a result, the last batter of the inning cannot be walked (intentionally or otherwise); the batter must put the ball in play or strike out.
- a. **If the last batter comes to the plate with 0 to 2 outs and proceeds to put the ball into play, the defensive team only has to obtain an out for the inning to be over.**
 - b. If the final batter in the order gets a hit, a defensive player must only touch home plate with possession of the ball to record an out and end the inning regardless of whether the play at the plate was not a force out. There is no requirement to tag the player at the plate for this circumstance.
 - c. In the final inning only, if the losing team is losing by more runs than players that they are batting (but less than the run rule limit) the losing team may continue to bat through the batting order until the game is tied. Once the game is tied, no more runs can be scored by that team.
 - i. Example: A team is losing in the final inning by 11 runs and batting 10 players. The losing team may bat through their batting order until 3 outs are recorded or the game is tied. The game is then declared over if the game does not become tied or the other team goes to bat to begin the next half inning, or start an extra inning, if the losing team ties the game.
 - ii. If the losing team is losing by fewer runs than they have batters, the losing team may bat through their order one time as usual and may take the lead.
 - Example: A team is losing by 8 runs in the final inning and is batting 10 players. The losing team may bat through their order one time as normal.
15. It will be the umpire and site supervisor's discretion to require a team to change pitchers if a pitcher's inability to throw strikes is drastically affecting the flow of the game. The umpire(s), site supervisor, and manager or acting-manager must agree that a pitching change is absolutely necessary. (As a **guideline** – five (5) walks in an inning or nine (9) walks through three (3) innings may be grounds for requiring a pitching change. However this is a guideline/suggestion. The purpose of this rule is to keep the game and players moving.)

SECTION E: Coed League

1. Teams must have the following amount of women in the lineup to play with the following amounts of players:
 - a. To play with 9 players – teams need a minimum of at least 3 women in the field and a minimum of 3 men in the lineup

- b. To play with 10 players – teams need a minimum of 4 women in the field and a minimum of 4 men in the lineup
 - c. To play with 11 or 12 players – teams need a minimum of 5 women in the field and a minimum of 5 men in the lineup
 - d. If a team starts a game with 3 or 4 women, all women must be playing in front of home plate.
2. If the minimum amount of men and women is not met, the game may start with a minimum of 9 players. However, an out is taken during the batting rotation for the missing player.
 - a. If the team has to take an automatic out, that out does not have to be at the end of the batting order.
 - b. **EXAMPLE:** A game starts with 2 women and 7 men. An automatic out is taken when then 3rd women's spot comes up in the lineup.
 3. The batting order must alternate male – female – male – etc... or female – male – female – etc... for the first 10-players. Depending on how you set up your rotation, it is possible to have three (3) men batting in a row if they are batting 10th, 11th, and 12th or 11th, 12th, and 1st.
 4. Male players may only substitute for males and females may only substitute for females. This applies to batting and fielding.
 5. A walk to a male batter (with a female batter to follow) will result in a two base award. The next batter (a female) will bat.
 - a. A male batter / runner advancing to second base without touching first base will be called out if properly appealed.
 - b. **EXCEPTION:** With two outs, the female has the option to receive an automatic walk or to bat.
 6. Infielders – teams may play players at pitcher, catcher, 1st base, 2nd base, 3rd base, short stop and one additional fielder. All other players are to be considered outfielders.
 7. Outfielders – including the short-fielder will play behind the Encroachment Line anytime a female batter comes to the plate. Outfielders can not go over that line until the ball has been struck.

16. SUSPENSIONS

1. The bats provided by the league are property of the Town of South Kingstown. Forcibly throwing/hitting a bat against the ground or other object for any reason will not be tolerated.
 - A. 1st offense – Team will be verbally warned
 - B. 2nd offense – Player will be ejected
 - C. 3rd offense – Team will forfeit game
 - D. Continued offenses by the same team throughout a season may be removed from the league without a refund.
 - a) A bat that is broken directly from throwing/hitting a bat against the ground or other object may result in the Town pursuing potential legal action for destruction of Town property.
2. A player or manager ejected from a game for taunting or other unsportsmanlike behavior and/or rule violation **is automatically suspended** from the next 2 games. Unsportsmanlike conduct includes any excessive chattering from the bench (i.e. swearing, arguing balls / strikes, harassing the call beyond a reasonable amount of time, etc...). **If the umpire is unable to identify the player violating these rules, the on-deck batter will be ejected from the game.** Play is suspended until the player leaves the facility. Failure to leave the park within five minutes will result in forfeiture of the game. Flagrant violation can result in suspension from two games to permanent suspension.

If such actions occur after the game in any area away from the field, the player or manager will receive an another games suspension.
3. Players ejected from a game as a result of discipline problems involving the umpire will be barred from playing in any league contracted with the umpire association until they are eligible to return to play in the league they were ejected from. Ejection will result in a one game suspension, second ejection will result in a two game

suspension, and third ejection could result in suspension from the league. Please note, this includes managers as well as players and the umpire jurisdiction includes off the field. Yearly suspensions are carried over from year to year and a player may be subject to multiple game suspensions for repeated violations not occurring in the same season.

- A. Team players and team manager are responsible for their fans. Unsportsmanlike behavior from fans may result in the ejection of the manager or based on the severity of the situation as determined by the site supervisor and umpires the forfeiture of the game.

4. THERE IS NO ALCOHOL CONSUMPTION AT ANY SOUTH KINGSTOWN PARKS

If any team members or affiliates with the team are observed consuming alcohol on park property the following will result:

First Offense – THE TEAM will forfeit their next game.

Second Offense – THE TEAM will forfeit another game and may be disqualified from the league. If the Parks and Recreation Department agrees to reinstate the team, a \$75.00 forfeit fee will be paid prior to playing the next scheduled game.

Third Offense – THE TEAM is automatically ejected for the rest of the year – including the fall softball season.

5. PROTESTS

1. **Field protests:** All protests must be made with the home plate umpire and the site supervisor in charge of the game at the time of the ruling. The site supervisor and the Umpire shall notify the other manager **IMMEDIATELY** that the game is being played under protest. The protest **must** then be filed in writing to the Parks and Recreation Department within twenty-four (24) hours following the completion of the game. Games protested on Friday or Sunday **must** be filed before 10:00am Monday morning or on the first business day if Monday is a holiday. A **twenty-five (\$25) dollar** protest fee **must** accompany the written statement. **Protests not having these two items (written statement and fee attached) will not be recognized.** This fee will be returned if the protest is honored. **JUDGEMENT CALLS MAY NOT BE PROTESTED.**
2. All decisions made by Parks and Recreation Department softball rules committee (Director, Recreation Superintendent, and Sports/Fitness Supervisor) regarding protests are final.

6. ASA RULES

South County Umpire Association is contracted through the Town of South Kingstown. ASA's rulebook will govern all aspects of the game, not specifically addressed by the South Kingstown softball rules.

7. PLAYOFFS

1. Except for the first game of the playoffs, the highest seeded team shall be designated as the home team for all playoff games. From the second game of the playoffs through the championship, the highest remaining seed will remain. home team status in each matchup.
2. There will be NO TIME LIMIT RULE during playoffs
3. The 12- and/or 20-run mercy rules are still in effect throughout the playoffs with the exception of the championship game/games. Championship games will be played out to completion.
4. **In Women's** – Batting through the order once is still in effect. However, if the game reaches the seventh inning, the batting order rule is suspended. In addition, batting through the batting order is **NOT** in effect for the championship game(s).

5. **To be eligible for post-season play, players must have played in at least 7 regular season games. There will be no exceptions for injury, work schedule, etc. A list of a team's attendance will be kept in the score booth with the softball supervisor.**
6. The better seeded team will be the home team in all games.

APPENDIX A – PLAYER ELIGIBILITY / ID REQUIRED

In the event a player's identity/eligibility is questioned at any time prior to the start of a game or during a game, the manager questioning must bring it to the attention of the home plate umpire and site supervisor. Once that has been done, the site supervisor will require the player to show a form of photo identification in order to verify that the player is on the team roster. If the player cannot produce a photo ID, he will be restricted from playing in the game and any future games until a photo ID has been shown; If a game has already begun, and it is determined that a player cannot provide proof of identity the team for which he is playing will forfeit the game.

APPENDIX B – Part 1 – CONCUSSIONS // INJURIES

Any player sustaining a head injury, or displaying symptoms of a head injury, as a result of a collision with another player, ball, the ground, or a bat **MUST** be seen and cleared by an EMT before resuming play. The player may decline care and/or transport by the EMT. However, please know that the EMT will require the player to sign off on the refusal of care. After the player's refusal, if it is recommended by the EMT that the player seeks care, the player will not be eligible to play for the remainder of the night.

APPENDIX C – Part 1 – BLOOD (Taken from ASA Rule Book – Rule #4 Section 9)

“A player who is bleeding or who has blood on their uniform shall be prohibited from participating any further in the game until appropriate treatment can be administered. If medical care or treatment is administered in a reasonable length of time, the player will not have to leave the game. The length of time that is considered reasonable is left to the umpire's judgment.”

If an EMT is called, the player may decline care and/or transport by the EMT. However, please know that the EMT will require the player to sign off on the refusal of care. After the player's refusal, if it is recommended by the EMT that the player seeks care, the player will not be eligible to play for the remainder of the night.

APPENDIX D- Part 1- UNDER THE INFLUENCE

Anyone who appears to be under the influence of drugs or alcohol will be unable to participate in the game and will be noted as under the influence by the field supervisor or umpires.
